SummerSlam Reading Jam Sweepstakes

OFFICIAL RULES

NO PAYMENT, ENTRY FEE OR PURCHASE REQUIRED.

OPEN TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES AND THE DISTRICT OF COLUMBIA. ENTRANTS MUST BE AT LEAST TEN (10) YEARS OLD BUT NO MORE THAN EIGHTEEN (18) YEARS OLD AT THE TIME OF ENTRY AND MUST ALSO BE MEMBERS OF A PARTICIPATING PUBLIC LIBRARY. VOID WHERE PROHIBITED.

ELIGIBILITY: Sweepstakes open only to legal residents of the fifty (50) United States and the District of Columbia who are at least ten (10) years of age but no more than eighteen (18) years of age at the time of entry and who are members of a participating public library. Employees, officers and directors of the Young Adult Library Services Association (“YALSA”) and World Wrestling Entertainment, Inc. (“WWE” or “Sponsor”), and their respective parent companies, subsidiaries, affiliates (*i.e.*, entities controlling, controlled by or under common control with, any of the foregoing entities), promotion and advertising agencies and anyone involved in the Sweepstakes’ development or execution, the immediate family members (meaning spouses, parents, siblings, children and their respective spouses) and members of the households of such employees, officers and directors and performing talent are not eligible. By taking part in this Sweepstakes, participants agree to be bound by these Official Rules. WWE reserves the right to permanently disqualify from this Sweepstakes any person it believes has intentionally violated these Rules.

HOW TO ENTER: Enter the Sweepstakes by being one of the first twenty-five (25) individuals to check out two (2) books from a participating public library between June 24, 2009 and July 16, 2009 (the “Entry Period”). (A complete list of participating public libraries is provided at the end of these Official Rules.) The first twenty-five (25) individuals to check out two (2) books from a participating public library during the Entry Period will receive a WWE mini-poster which has a number printed on the front (the “Poster Number”). Posters will be distributed by each participating library on a first come – first serve basis. Only one poster per person. In the event of a dispute as to the identity of the holder of a poster, the poster will be deemed to belong to the library member who returns to the library with the poster. If a dispute cannot be resolved, the entry will be deemed ineligible. **NO PURCHASE NECESSARY.** A purchase will not increase your chances of winning.

DRAWING: On July 17, 2009, WWE will randomly select two (2) Poster Numbers as Grand Prize Winners, ten (10) Poster Numbers as First Prize Winners and an additional fifteen (15) Poster Numbers as alternates. At 3:00pm Eastern Time on July 17, 2009, WWE will post these winning and alternate numbers on its website at WWW.WWE.com (the “Website”). Two (2) Poster Numbers will be listed as Grand Prize Winners, ten (10) Poster Numbers will be listed as First Prize Winners and fifteen (15) Poster Numbers will be listed as alternates. Winners and alternates will be listed in order of priority in the event that a prize or prizes are not timely claimed, as described below. Each participant must check the posted Grand Prize, First Prize and alternate numbers against his or her Poster Number. Note that if a participant’s Poster Number matches an alternate number listed on the Website, he or she is not automatically qualified to receive a prize. If a participant’s Poster Number matches one of the Grand Prize numbers, one of the First Prize numbers or one of the alternate numbers, the participant must return to the participating library from which he received the poster **no later than the close of business on Wednesday, July 22, 2009** and show his or her poster to a librarian. The librarian will verify whether the

poster has one of the winning or alternate numbers printed on it. If the poster indeed has one of the winning or alternate numbers printed on it, the librarian will ask the potential winner for his or her name, address, email and telephone number and will call WWE with such information. Failure to return to the library with a poster containing a winning or alternate Poster Number on or prior to **Wednesday, July 22, 2009**, for any reason, will result in forfeiture of any potential prize. If either or both of the Grand Prizes remain unclaimed at the end of Wednesday, July 22, 2009, the First Prize Winners will move up, in the order that they are listed on the website, so that one or two First Prize Winners, as applicable, are upgraded to Grand Prize Winners. In the event that either (i) two (2) Grand Prize Winners are not confirmed or (ii) after two (2) Grand Prize Winners are confirmed, there are fewer than ten (10) First Prize Winners, WWE will award the remaining prizes to alternate winners in the order in which they were listed on the Website. Alternates who become prize winners will be notified on or about Friday, July 31, 2009. WWE will mail each First Prize Winner his or her prize no later than four (4) weeks following each First Prize Winner's confirmation as a winner. The Grand Prize Winners will be required to complete and sign an Affidavit of Eligibility, a Liability Release and, where legal, a Publicity Release, and any other documentation that Sponsor may require and to see to it that Sponsor is in receipt of these documents within three (3) days of having received the same. PRIZES: Two (2) Grand Prizes: Two (2) Grand Prize Winners will receive a trip for two (2) to Los Angeles, CA for Grand Prize Winner and one (1) guest to attend WWE's SummerSlam live event currently scheduled for August 23, 2009. Each trip includes roundtrip economy class air transportation for Grand Prize Winner and one (1) guest over the age of twenty-one (21) to Los Angeles, CA from a major commercial airport near Grand Prize Winner's residence; two (2) nights' standard hotel accommodations (standard room, double occupancy); two (2) tickets to the SummerSlam event; and \$200 spending money. Approximate retail value ("ARV") of each Grand Prize: \$2,000.00. Actual value will depend on point of departure and any airfare fluctuations.

Air transportation to Los Angeles, CA provided only if Grand Prize Winner resides at least 100 miles from Los Angeles, CA.
